TERMS AND CONDITIONS

- A. This application entitles the undersigned entity (Applicant) to apply for participation in the Corporate Links Club (Club). This application will not be acted upon by Half Moon Bay Golf Links (HMB) until completed, executed and accompanied by payment in full of the annual fee. Applicant must be a bona fide business entity not involved in the golf industry, golf brokerage or travel businesses.
- B. Participation in the Club entitles a qualifying entity to provide to its designated partners, officers, directors, shareholders or employees (Designees) those benefits, services and privileges specifically identified as "Corporate Links Club Benefits & Rates" in Club brochures published from time to time. Entities accepted into the Club program will be entitled to two "Designees", unless additional Designees are purchased by Applicant and approved by HMB. Approval of all Applicants will be at the sole discretion of HMB. Designees may be transferred a maximum of once per year unless otherwise approved by HMB. All Designee changes are subject to the then prevailing transfer fee.
- C. Applicant acknowledges and agrees that use of HMB facilities may be restricted from time to time, and that use, service, rates or other published charges may vary from time to time at the sole discretion of HMB. Club participation does not convey or create any ownership, management, control, voting rights, equity interest or other rights, interests or entitlements in HMB or HMB facilities.
- D. Applicant may renew participation in the Club at the end of each one year term by paying the then prevailing program annual fee. HMB retains the right to change the benefits, services and privileges of the Club at any time, and may terminate the Club program at any time by giving Applicant 30 days notice and refunding the prorated portion of the annual fee unused. No other reimbursement, refund or payment will be due.
- E. Guest play authorized by Applicant is a maximum of 12 guests per day at the then prevailing guest rate offered to Club participants. Guest play exceeding 12 guests per day is subject to availability and preferred tournament rates of 15% off published rates unless authorized at a lower rate by HMB.
- F. Applicant agrees to be liable for all charges incurred by its Designees and guests. Applicant acknowledges and agrees that its Club account shall be considered delinquent if not paid within thirty (30) days after the date of the monthly statement and will be subject to a one and one-half percent (1.5%) interest charge per month from the date of the monthly statement until paid in full. Applicant also acknowledges that HMB may take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of Club privileges or legal action, and Applicant shall be liable for all costs and expenses of such legal action, including reasonable attorneys' fees.

PAYMENT OF ANNUAL FEE AND MONTHLY CHARGES

Applicant agrees to pay the nonrefundable annual fee of \$ 5,000 to participate in the Club. The annual fee entitles Applicant and its Designees to the benefits, services and privileges of the Club program for a period of one year from the date the application is accepted by HMB. Following each annual term, Applicant may renew its participation by paying the then prevailing published fee for the Club program. HMB has a program whereby qualified Applicants may charge for services, food, beverage, guest fees or merchandise to an account established by HMB. Applicant understands that it must pay the monthly statement of charges within 30 days of receiving the billing statement. Applicant also understands that this statement can be paid by a credit card on file with HMB to which Applicant authorizes HMB to charge such fees and charges by selecting this option below.
